1. That we have visited the campus, seen the facilities including hostel, medical, mess, school, SSB ground, Playground etc. and understood the Admission Guidelines completely. We have read and understood the Academic Rules and Regulations and have found them to be appropriate and the same have been explained to our child seeking admission as well.
2. We do hereby agree and declare that we have permitted our child as mentioned above to take part in any camp/activity/tours and treks/competitions/swimming/NCC/ mountaineering/rock climbing/hiking and other games/sports or any activities which involves risk, organized by the academy and undertake and agree to hold the academy and its staff indemnified against all such claims that may arise out of any loss or injury to the property or person (including injury resulting in death) which my daughter / son/ ward may suffer in consequence of participation in any such or any other academic activity.

3. **That we understand that despite all precautions and efforts things could go wrong by the Will of God or some unfortunate misfortune or accident.**
4. **That we understand the risk involved in sending our child to a boarding school/hostel to study and hereby indemnify DEHRADUN NATIONAL ACADEMY OF DEFENCE, DEHRADUN, UTTARAKHAND, it's Management, Director, Head of Academy, Teaching or Non-teaching Staff, Coaches, Guides, Servants, other Employees and all such people who may be looking after and taking care of our child from and against all proceedings and claims for any disability, bodily injury (self-inflicted or otherwise), due to any accident, infighting, health problems, running away from the campus, suicide and/or suicide attempt, death, infections and diseases caused by any insect-bites, animal-bites, plant-bites or otherwise (in or outside the campus of the academy) and from and against all damages, losses, costs, charges and expenses in respect thereof, in any manner due to any reason, whatsoever, that my son/daughter may suffer as a hostler, boarder and/or day-boarder.**
5. **We, hereby further affirm that our child who seeking to be admitted to DEHRADUN NATIONAL ACADEMY OF DEFENCE, DEHRADUN, UTTARAKHAND is medically fully fit to live alone in the hostel and does not need any special medical attention or care and has no communicable or serious diseases like that of skin problems, fits, asthma, heart problems, sleep-walking or suffers from any sort of attacks or likewise or any kind of psychiatric problems like mental trauma or depression or any other sort of medical problem. We declare that our child is mentally, physically and emotionally fully fit to undergo the stresses related to hostel life.**
6. **That we completely understand that some children may not be able to take such stresses and we shall willingly withdraw our child on the advice of the Head of Academy or the Management of the Academy whose decision in the matter shall be final and binding on us.**
7. **We, hereby indemnify DEHRADUN NATIONAL ACADEMY OF DEFENCE, DEHRADUN, UTTARAKHAND and all its employees for any injuries, fatal or otherwise, sustained by our abovementioned child while boarding, alighting or travelling from or in the Academy transport or any other mode of transport organized by the Academy or the organizers within or outside the campus or while taking part in Exchange Programmers/Educational/Adventure trips, studies, sports, or any other form of activity within or outside the Academy premises.**

8. **We, hereby undertake to indemnify DEHRADUN NATIONAL ACADEMY OF DEFENCE, DEHRADUN, UTTARAKHAND, from and against all the responsibilities, liabilities and legal implications of any law of the land for the time being in force or otherwise, in any manner; in case of my son/daughter possessing, using or dealing with any kind of intoxicating material including alcohol, drugs of any kind, gutka, tobacco, cigarettes or any other sedative materials; or in case of my son/daughter possessing, using or dealing or abetting the use of any kind of items or having in possession any weapon/s including sticks, rods, explosives, firework or any such material.**
9. **We also understand and agree that no compensation will be paid by the Academy in respect of any such loss or injury and expenses if any incurred in the treatment of such injuries will be borne by us as parents/guardians of the child.**
10. **We have gone through and understood the Academy regulations/directives which have banned Ragging, Bullying and Sexual Offences. We are aware that the Academic advocates and implements measures to prevent any such happening and that these are non- negotiable offences. We assure you that our son/daughter will not be involved or indulge in any improper act that may come under the definition of serious offenses as determined by the Head of School or the Management. We also fully understand that in case our son/daughter should be found involved in any such incident within or outside the premises of the academy, strict action shall be taken against him/her as determined by the Head of academy or the Management, which may even lead to an immediate expulsion or lodging of an FIR.**
